

CONSENT TO PERSONAL DATA PROCESSING

By filling out the feedback form on the website www.himterra.kr-rb.ru the user assumes an obligation to accept the Consent to personal data processing (hereinafter – Consent). The acceptance of the Consent is given by providing personal data in the feedback form, published on the website. The user gives his consent to the “Development Corporation of the Republic of Bashkortostan”, owning the website www.himterra.kr-rb.ru and located at the address: 450077, Russia, Republic of Bashkortostan, Ufa, Pushkina str, 110, to process its personal data on the following terms:

1. The following Consent is given for personal data processing both with and without the use of automatization means.
2. The Consent to personal data processing of the user is given only and exclusively with the purpose of replying to the requests of the user forwarded through the feedback form on the website.
3. The legal basis for personal data processing is Clause 24 of the Constitution of the Russian Federation; Clause 6 of the Federal law №152 “On personal data”.
4. The Consent is given for the processing of the following data:
 - Last name, First name, Patronymic
 - Numbers of contact phones
 - Emails

In the course of personal data processing the following activities will be undertaken: gathering, recording, systematization, accumulation, specification (updating, revision), extraction, usage, transfer (distribution, provision, access), depersonification, blocking, removal, deletion – all the aforementioned activities are implemented only with the purpose, provided in Clause 2 of the Consent.

The transfer of personal data to the third parties is implemented on the basis of the legislation of the Russian Federation or with the permission of the user.

6. Personal data are processed prior to the completion of all the required procedures. Besides, data processing can be terminated at the request of the user. Storage of personal data, recorded on paper, is provided in accordance with the Federal law № 125 “On the archive keeping of the Russian Federation” and other legal acts in the field of archive management and keeping.

The Development Corporation of the Republic of Bashkortostan takes all the required measures to protect personal data of the user from illegal access, change or deletion.

7. The Consent is also given to the possible transboundary transfer of personal data and information (commercial) notifications.

8. The Consent can be withdrawn by the user or his representative by means of directing a written declaration to the Development Corporation of the Republic of Bashkortostan or its representative to the address, specified in the preamble to the Consent.

9. In the event of withdrawal of the Consent to the personal data processing by the user or his representative, the Development Corporation of the Republic of Bashkortostan has the right to continue the processing without permission of the user provided it conforms to points 2-11 part 1 clause 6, part 2, clause 10 and part 2 clause 11 of the Federal law №152 “On personal data” as of 26.06.2006.

10. The given Consent is effective all the time till the moment of termination of data processing for the reasons, specified in point 9 of the document.
